TERMS AND CONDITIONS

Information on how to enter and participate forms part of these Terms and Conditions.

Participation in 'Mildura Central's St Patrick's Day' Promotion is deemed acceptance of these Terms and Conditions.

WHO CAN PARTICIPATE?

1. Subject to Condition 2, this Promotion is open to people aged 13 years or over.
2. Parents/ Carer/ Guardian must be present for people under the age of 12 years in order for them to participate in the Promotion.

PROMOTION PERIOD

3. This Promotion will run continuously from 9:00am on Wednesday the 8th of March 2023 until 9:00pm on Friday the 17th of February 2023.
4. Participation in the Promotion is not offered outside this Promotion Period.

ELIGIBILITY DETAILS

5. Entry is only open to residents of Australia.
6. To be eligible to participate in the Promotion, all Participants must either:
 - a. Complete an entry form available at the Promotion site, answering all questions fully.
 - b. Place their entry form into the Promotion barrel.
7. Participants must complete all steps listed above, or risk having their entry cancelled.
8. Entries are limited to one entry, per Participant, per day throughout the Promotion Period.
